#### Key points

- Indian civil service exam plays important role in shaping curricular priorities
  - Universities, textbooks, coaching programs
- We examine the optional papers on public administration for 2009 to 2018
- Three findings:
  - Heavy emphasis on American public administration
  - Neglect of international experience other than US
  - · Content is out of date
  - Mismatch between theory and practical concerns identified in papers

# Structure of PA optional papers

- One of the most popular of the 26 optional subjects
- Syllabus published before examination
- Paper I: Administrative Theory
- Paper II: Indian Administration
- Typically about eight questions in each paper
- In 2009-2018, 492 questions or sub-questions

### Theory questions

- Of 58 individuals referenced, 41 are American
- Most of the non-Americans are politicians or bureaucrats
- 48 of the 58 people referenced are dead, half have been dead for at least a quarter-century
- Questions reflect American PA curriculum of late 1960s and 1970s
- Omitted: Public Policy literature post-1970s, Public Management literature post-1980s, literature on P3s, networks, non-profits
- Included: macro- and micro-level topics
